EIDXA REPEATERde WOMJN

It has been nearly six years since we put the EIDXA repeater on the air in 1981. Those of you who were members of the EIDXA at that time will recall that our repeater project was made possible by passing the hat among the membership for financial donations, a donated 150 watt PA, and a lot of time and effort from Al Groff (KOVM) and Bob Hill (WANIM) to put the repeater on the air. Considering the length of time that we have had the 145.19 repeater on the air, the maintenance and operating expenses that we have incurred over the years has been very minimal. Al and Bob have continued to provide the maintenance and Bob has been donating the electricity and tower space for the transmit site.

As many of you now know, our 145.19 repeater has recently been plagued by chronic PA problems; and with the PA's most recent failure, it is now beyond repair. To say it bluntly: the old PA is dead, we need to buy a new PA, it will cost \$250, so it's time to again pass the hat. Prior to the last meeting, the repeater fund had a balance of \$69. During the last meeting, the hat was passed and an additional \$42 was collected, increasing the balance to \$111. Of the \$111 balance, we spent \$90 for new PA transistors the last time the PA got sick, leaving a current balance of \$21. Considering the size of our club, the minimal club dues, the coverage area of the repeater, and the dollars we each spend on HF gear and QSL cards, I don't think it is unreasonable for each of us to kick in \$6 to \$10 at the next club meeting to get our repeater back to good operating and good coverage condition.

When the hat is passed at the next club meeting, keep in mind that the EIDXA is your club and that the 145.19 machine is your repeater. They are your responsibility too, not just the other guy's. Be generous so we can keep the machine on. Consider contributing the cost of a few hundred QSLs. If you can't make the meeting, send a check to WOIZ and let him know it is for the repeater fund.

From the VP - de KFOZ

The infamous Mr. Jaksa is manipulating my quilt over not being available to produce the first issue of the newsletter as stipulated in my job description. He seems to think that one can snatch these things out of thin air. But then again, of course, being haws, we're all accustomed to snatching things out of thin air, aren't we? In fact, this past weekend, after a longish full in activity (most of the last two years?). I found myself getting hooked by the 1986 10 Mater Contest. I have never run very high power (200 - 220 watts input; who knows what out?). After moving across metropolitan Mt. Vernon this summer, I have only had occasion to put up a fairly large dipole (90-foot legs, inverted vee configuration, center point (inside the attic!) up about 30 feet). To make matters worse, I am well down a hill that rises to my northwest and is covered with trees (an aesthatic boon, but a minor propagation disaster). What kept me from getting out of the habit of getting on the air altogether this summer during the move, an endless wait for the room destined to be my shack/office/study finished out, cataract surgery (I couldn't read for a month or so), and the adoption of a toddler from Central America, was packet radio. My second best two meter rig, my computer, and my second best mag mount antenna first sat on a window air conditioner at the old house, and then on a bookcase in an upstairs bedroom at the new house, while I plumbed this weird new mode.

I could always hit SOMETHING that would allow me to digipeat to the local bulletin board or to those I wanted to talk to in CR and along the more dependable digipeater routes in surrounding areas. This is a mode that takes some figuring out. Between TNC's, computers, modems, an entirely new jargon, and some conceptual differences from anything else I've tried, it took a goodly while to figure out. It kept a mild hankering for RTTY and other bands alive in me, though, and once established in the new shack, getting on RTTY got me to wanting to get back on CH (ragchewing on 30 meters and chasing DX wherever), antennas notwithstanding.

This all came to a head during the 10 meter contest. I didn't do much in that contest. I didn't have the time and propagation was the pits. But there was the old challenge to do as well as I could with what I had when I had the chance. For years I kibitzed in any contest I might stumble across. I even took the rig to Waldoboro, Maine one summer and got \$2 mixed mode award for the state of Maine in the first Radiosport I had ever entered (I could have gotten \$1 CM if I had known that no one else had entered that category!) as KFOZ/1. I used my Ten Tec Delta barefoot to a 75 meter dipole borrowed from KBOPR, about 110 feet of bare braid strung over the branches of scrub pines at a mean elevation of about seven feet. I was so far east that the only thing due south of ma was Brazil. When the bands went out for the big guns, they were still open to se for as such as an hour. I have sent innumerable 40 and 80 meter CW QSL's to Ukrainian and Yugoslav stations who worked me when I was the only thing in North America they could hear. From Iowa, I've never worked ANY DX on 40 or 80! I didn't really believe it was possible.

But back to the contest. As little as I had, I finally had a working station set back up. My CW was rusty, but there were virtually no signals on SSB (WOEJ doesn't count). The QSB was so quick during the short intervals when I had time to operate that it was possible to tune down the bottom 100 kHz and hear NO signals, then tune right back through again and hear four or five. Sometimes they would be in South America and Texas, sometimes New England, and sometimes California. After getting tired of trying to crack piles or guess whether I was strongest to the station I was calling when he was strongest to me, I started noting the frequencies (last three digits to 100 Hz), calls, and last heard serial number. I'd call twice then move on. Sometimes I got them when they were almost inaudible, sometimes when they were peaking here. Tail-ending KJOH when I could hear him worked a couple of times. To give you some idea of what a handicap my hill might be, NCOO was the weakest station I think I have EVER successfully worked on CW. I told him in a message on the packet bulletin board that I would expect a stronger signal from a SUBMERGED Russian sub. He is less than 20 miles from GP.

I wound up with a lordly 20 0's, and I probably spent 5 hours total working that few. Still, it had been a long time and more fun than a lot of the intermittent operating I have done in the last couple of years (CW ragchewing still comes in a close second to contesting; but not all THAT close). I managed to bag a CE and an LU, and some of the M5's and M6's were even harder to work. I think I'll look around for some more contests, especially on CW and RTTY. Even with a low wire and low power, I'm still crafty enough to get in if I'm patient and figure out patterns of operation. I'm still surprised how many people rely on brute force and repetition to make a contact.

Sooner or later I'll put the beam back up along with some bigger wires (I finally have ROOM for them!). But that really doesn't matter so much as the adrenaline rush of all those folks out there making as many contacts as possible in as short a time as possible. There ain't nothing quite like it.

So, if you have the DX or contest blahs, and haven't been in the pileups recently, you might find that if you force yourself to sit down at the rig (and the EIDXA net on Monday nights at 9 is a good place to find out when those times are), you might find as I did that the old thrill is still there! You might not take a first for your call area, your state, or even your town (if you live in Cedar Rapids or Marion, especially!). But it would still be fun to see if you can do better in a four-hour period than you've ever done before! Or even as well as you did in your heyday! Give it a shot!

From the President - de WOVX

Well, here I am again, editing another issue of the EIDXer! Jan, KFOI, his growing the family are off to New England for the holidays so I'm covering. Next issue will be Jan's!

One of my goals for the club during my term as president is to get as many people active in the club as I can. Part of what we will be doing is spreading around the club responsibility. The Net Manager and Refreshments Chairman positions are a start but we need more basic activity if we are to survive. What is the point in belonging to an organization if you are not active in it? Yeah, its always good for a line on a resume but so what?

It's tought to be an active DXer when the spots are at a minimum. These kind of conditions sort of separate the DX men from the dx boys. But take heart! Cycle 22 is upon us. One of the more interesting recent ARRL Propagation Bulletins is reprinted in this issue as it gives hope that things will get better soon.

As you no doubt noticed on page 1, we are making a small sodification to the meeting format. The coffee will be on early and we will start to gather at 7:00 for a social half hour before the business meeting. This will give us all a chance to visit with members we don't see very often. Come join us and meet the members, swap lies, etc. The business meeting will start promptly at 7:30 and hopefully last no longer than 1 hour. Following a short break we will have the program on contesting by WOEJ.

We are also contemplating a mini tech topic program program of 1/2 hour length to augment our usual DX/Contest programs. We would in essence have 2 programs each meeting. One short technical session and one longer one on DXing or Contesting. The big problem will likely be controlling the time. If things ranble on we will have a meeting that lasts until midnight. Please let your board know what you would like to see.

While we are on the subject of meetings, the contract that we sign with the REC for our meeting room stipulates that we must return the room to the condition we find it in. Of late there has been a small problem with clean up. Please do your part to put the chairs away and generally straighten up the room. How clean does it have to be? Well, just pretend the XYL will be giving it the "white glove" test! We have a good no cost meeting place. Lets not blow it!

During December I received a letter from ARRL Headquarters indicating that a few of our members were no longer current ARRL members and because of that we no longer qualify as a 100% club. To refresh your memory, our constitution requires that you be an ARRL member in order to hold membership in the EIDXA. (You also must be an ARRL member to hold DXCC and to use the outgoing QSL Bureau!) Dropping your ARRL membership will result in being automatically dropped from the EIDXA. Those in question were send a letter advising them of the situation and the fact that they would be dropped from the

club unless they renewed with the ARRL. The new member list on page 4 reflects this action and deletes those who chose not to renew. By the way, dues are due NOW.

ARRL renewals can be handled through the EIDXA. We get to keep \$2.00 for each club member who renews through the club. To renew send your renewal notice and check made out to the EIDXA to Dale, WOIZ. He will put \$2 in the treasury and send the rest to HQ. Its a neat way to help the club and it doesn't cost you a cent!

The Iowa Section Manager elections are upon us. Unless you have spent the last couple of months on Peter I Island, you know that our own Nade, NOEJ is running against the current SN Rollie, WBOAVN. Both are fine men with differnt skills and ideas. Wade is obviously more DX and contest oriented and Rollie is more net and public service oriented. You are encouraged to study the candidates and vote for your choice. As with most elections, the local ones are the most important. You should have your ballot by now. As the big boys say, vote and the choice is yours, don't vote and...

Contest scores for the Fall contests are shown elsewhere in this issue. To say the least, participation is down! It is tough to get enthused when propagation is down. There is, however, lots of fun and DX to be had. The ARRL DX Contest is coming up in February and March. Forms are in this issue so why not give it a shot for a couple hundred QSOs or so. Since the EIDXA constitution was modified several years ago, you are no longer required to participate in 2 contests per year to retain membership. But you are still encouraged to participate in the DX contests and contribute to the club score. It won't kill you and it will help the club make a decent showing.

As you saw on page 12 of your January QST, there is a special sticker to commemorate the 50th anniversary of DXCC. Although we don't have firm pricing yet, initial indications are that the stickers are quite expensive (about 6 cents) when ordered 1,000 at a time. The price drops to well under 2 cents each when ordered in quantities of 15,000 or 25,000. The preliminary info I have indicates that the price will be \$16-18 per 1,000 in these larger quantities. The samples they sent me are really classy looking but unfortunately they are not exactly like the sticker we want consequently the pricing may not be exact. We will have exact pricing at the meeting so if you want to class up your QSL this year as you go for the special 50 year DXCC award, bring along some \$. If things work out, we will place the order with the company immediately after the meeting. To simplify things, we will only take member orders for lots of 1,000 so if you only need 500, talk to a friend.

Once again this year we will be planning a late spring / early summer EIDXA Banquet. Since there are several new places to choose from we will likely be holding it in a different location this year. If you have suggestions for a program, would like to be on the committee, or would like to chair the committee, please let one of the officers know.

October 3, 1786 Minutes

Meeting was called to order by President KOVZR at 7:45. Those present were: KUOA, WDOAWL, WOVX, KFOZ, KOIIR, WOSR, W4NIN, NKON, KFOH, KZOC, WOEJ, KOAL, KOEVB, NBOH, KCOO, NCOO, NUOP, NOSOB, KEOM, WAPYZN, WOIZ, WOUZ, KOJSH, KAOWKT, KDORT, NGOW, KOVM, KJOH, WOWP, KEOY, KORW, KOVZR, & KCGT.

A action to accept the previous minutes as published in the EIDXer was made by KOAL and seconded by NANIN.

Treasurer reported a balance of \$108.83 not including dues collected prior to the meeting.

WANIM reported repairs were made to the repeater antenna but that amp problems resulting from mismatch were still in process of being repaired. Expenses will deplete the repeater fund. KOAL made a motion to replenish the repeater fund. Second by WOEJ. \$41.00 was collected.

Contest committee report was in the newsletter. WOEJ suggested the club consider participation in the lowa QSO party.

WOSR reported on DXAC activity. ARRL July board meeting approved special DXCC award commemorating 50th anniversary of DXCC. Aruba independence official in 1996 but country recognition earlier is slim. TP2I, Council of Europa, does not appear to meet criteria for country status. Terra del Fuego is being considered. The 4U1VIC issue continues to be pressed. The Alaskans are still trying for recognition of the Pribilof Islands. The July ARRL board meeting passed a resolution considering restructuring DXCC. WOSR encouraged all to write ARRL to let their ideas and feelings be known.

KFOH was nominated for membership by KOAL and second by WOEJ. Motion passed.

Nominations opened for President. WOVX was nominated by KFOZ. KCOB was nominated by MOEJ. WOVX was elected President.

Nomination of KFOZ for Vice President was made by WOIZ. WANIM moved moninations cease. WOEJ second. KFOZ was elected Vice President.

Nominations for Sec-Treas opened. WOVX nominated WOIZ. WOSR moved nominations cease and WOEJ second. WOIZ was elected Sec-Treas.

KEOY suggested the club sponsor an award. WOSR suggested W4VQ be contacted about a 5 Band Century Sweep award where the same country is contacted on each of 5 bands.

KOGVB invited all to the West Liberty Ham Fest Oct. 5.

A petition to nominate WOEJ as Iowa Section Manager was bassed.

Congratulations to KOGVB for achieving Iowa's first 160 meter DXCC.

WOEJ moved for adjournment and second by WANIN.

KOAL presented an informative and enjoyable slide program of his European bicycle trip.

FCC NEWS

The good news is that the FCC will soon allow written examination credit as soon as the 610 form is modified. The bad news is that the Office of Management and Budget has not approved changes to FCC form 610. As soon as the new form is approved partial exam credit will be issued for the written portion as well as the code portion.

License renewals continue to confuse some of us. If you have a 5 year license, you can renew up to 5 years after expiration without having to retake an exam. If you have a newer 10 year license, the grace period is only 2 years. Either way, you will get a new call sign if your license has been expired for 2 years or more.

Business communications via amateur radio continue to be a hot and sometimes confusing issue. In general it is considered business communication, and not permitted on ham radio, if it facilitate the regular business afairs of any party whether for profit or not. The exception to this prohibition is emergency communication where safety of life or property is involved. The FCC we should not use amateur radio as an alternative to other services including common carrier. Better not order that Pizza on the autopatch!

FCC will rely on state and regional repeater councils for coordination. The coordinator must have support from the majority of those repeaters in its area. Stations operating with illegitimate repeater coordination risk FCC sanctions if interference occours. (WOMJN/R is a coordinated repeater.)

FCC has modified its rules to permit smployees to accept meals and refreshments offered at group functions if 1-the function has some business context, 2-it is a group function, 3-cost associated with the function are not lavish, 4-attendance by FCC staff does not result in or create the appearance of impropriety or undue influence. FCC will determine in advance if attendance is desirable to assist the commission in performing its duties.

A SOLAR CALM THAT BEGAN IN LATE NOVEMBER IS STILL WITH US. SUNSPOTS ARE FEW AND FAR BETWEEN. THE SOLAR FLUX MOVES UP OR DOWN ONLY SLIGHTLY, BUT IT REMAINS MOSTLY ABOVE 70, HIGH ENOUGH TO KEEP DX COMING ON 21 MHZ DAILY AT THIS TIME OF YEAR. IT IS TOO LOW TO DO MUCH FOR 28 MHZ, HOWEVER. WE NEED ANOTHER EIGHT TO TEN POINTS HIGHER TO DO MUCH FOR THAT BAND, EXCEPT FOR TIMES WHEN E SKIP IS IN AS IT HAS BEEN OFTEN OF LATE. THE CURRENT SOLAR ACTIVITY LEVEL IS IDEAL FOR DX ON THE LOWER BANDS, AND 160 IS PROBABLY BETTER NOW THAN IT WILL BE FOR ANOTHER SEVEN OR EIGHT YEARS AFTER THIS NORTHERN HEMISPHERE WINTER IS OVER. 80 AND 40 WILL PROBABLY REMAIN GOOD FOR LONG HAUL WORK FOR ANOTHER YEAR OR MORE.

SOME STATISTICS ARE NEEDED TO EXPLAIN WHAT IS HAPPENING CURRENTLY. WE ARE IN THE OVERLAPPING PERIOD BETWEEN TWO SOLAR CYCLES, NEW CYCLE ACTIVITY HAVING APPEARED SEVERAL TIMES RECENTLY. THIS APPEARS TO EXPLAIN THE FACT THAT WE ARE RUNNING ALONG SLIGHTLY, BUT SIGNIFICANTLY, ABOVE MINIMUM SOLAR FLUX LEVELS. SINCE SEPTEMBER, 1985, THERE HAVE BEEN FOUR MONTHS WHEN THE SOLAR FLUX AVERAGED UNDER 70. THEY WERE SEPTEMBER 1985, AND JUNE, AUGUST AND SEPTEMBER, 1986. THE FIRST DAY UNDER 70 WAS SEPTEMBER 29, 1984. IT COULD BE THAT WE WILL NOT SEE ANOTHER FOR A LONG TIME.

EARLY THIS WEEK WE MAY HAVE A SLIGHT FLUX RISE, BUT PROBABLY NOT ENOUGH FOR A SIGNIFICANT PROPAGATION CHANGE. A MINOR GEOMAGNETIC DISTURBANCE BEGAN SUNDAY AFTERNOON, BUT THERE SHOULD BE MOSTLY GOOD CONDITIONS THROUGH THE FIRST HALF OF JANUARY.
