A FEW DAYS AGO YOU PROBABLY RECEIVED A SPECIAL EDITION OF THE NEWSLETTER ADRESSING THE NEW BYLAWS AND CONSTITUTION. AFTER MAILING THAT NEWSLETTER OUT WE NOTICED THAT AN ERROR HAD CREPT INTO THE WORDING OF THE BYLAWS. THE ERROR IS IN SECTION III PARAGRAPH 4E ENTITLED "MAINTENANCE OF FULL MEMBERSHIP". THE PARAGRAPH ADRESSES THE TWO METHODS FOR MAINTAINING FULL MEMBERSHIP IN THE EIDXA. THE SECOND METHOD IS THE ONE AFFECTED AND IT SHOULD READ:

2: A FULL MEMBER MUST PARTICIPATE IN AND SUBMIT AND HAVE PUBLISHED A VALID SCORE IN THE ARRL \underline{DX} CW OR PHONE COMPETITIONS OR THE CQ WORLD WIDE \underline{DX} CW OR PHONE CONTESTS. THE RESULTS OF THE CONTEST MUST HAVE BEEN PUBLISHED IN THE JUST COMPLETED EIDXA YEAR.

I HAVE UNDERLINED THE CHANGES IN THE WORDING, ALL WE DID WAS ADD THE WORD "DX" TO BE SURE THAT EVERYONE UNDERSTOOD WHICH CONTESTS ARE SPECIFIED.

IF YOU ALREADY HAVE SENT YOUR BALLOT INTO NOØO AND WOULD LIKE TO CHANGE YOUR VOTE THEN SEND IN THE MODIFICATION BALLOT ATTACHED BELOW. IF YOUR VOTE REMAINS THE SAME THEN YOU HAVE NOTHING TO DO. PLEASE BE SURE YOUR VOTE IS INTO NOØO BY JULY 15 SINCE THE EXECUTIVE COMMITTEE IS GOING TO MEET AND DETERMINE THE RESULTS.
